

- Q: What are the rules that pertain to the retention of call detail records by telecommunications/information services providers in the United States?
- A: For entities that fall under the jurisdiction of the Federal Communications Commission (the "FCC"), "[e]ach carrier that offers or bills toll telephone service shall retain for a period of 18 months such records as are necessary to provide . . . billing information . . .." (47 C.F.R. § 42.6).

In addition, providers may be subject to individual State jurisdiction based upon their services and activities. Therefore, the following information applies to providers that fall under the jurisdiction of the particular State.

Each provider should follow the guidelines below and also, providers should maintain call detail records for a period of time that corresponds with their back billing policies (if they extend past the Federal or State requirements).
